A change in the standards regulating operating room humidity levels may conflict with the instructions for use on some equipment and supplies routinely used in surgery. ASHE has collaborated with the American Hospital Assn. and the Association for Healthcare Resource & Materials Management to develop an advisory explaining the issue and giving members guidance on how to proceed.
